

Welcome to Jakarta for the twelfth meeting of the Asia Dialogue on Forced Migration (ADFM). We are delighted to be meeting again in person for the first time since 2020. Our twelfth meeting is taking place from 16-17 May 2023 at the Mandarin Oriental Hotel, Jakarta, and will include the ADFM Dinner from 7-9pm on 16 May, hosted by the Indonesian Ministry of Foreign Affairs.

Established in 2015, the Asia Dialogue on Forced Migration (ADFM) is an independent Track 1.5 forum for genuine dialogue on the critical forced migration issues facing the region. The ADFM has contributed to changes in governance, policy and practice benefiting refugees, stateless, and trafficked persons, in partnership with the region's institutions and national governments.

The ADFM has met nine times in person in capital cities around the Indo Pacific region. Our last in person meeting was in Dhaka, Bangladesh in February 2020, when the ADFM Secretariat made its second visit to Cox's Bazar to follow up on our 2018 assessment of the risks of human trafficking and migrant smuggling arising out of the long-term displacement there.

During the pandemic the ADFM continued to meet virtually, including to discuss boats stranded in the Andaman Sea at the start of 2020, revitalising the Bali Process on its 20th anniversary in 2022, and the displacement crises in Afghanistan and Myanmar. In 2022 the ADFM Secretariat released its report *Future Ready*, outlining eight proposals to reform the Bali Process to prepare it for the future. We were pleased to see progress at the eighth Bali Process Ministerial Conference in Adelaide, Australia in February 2023, including activation of the Consultation Mechanism in response to the increase in dangerous boat movements in the Andaman Sea.

The ADFM Secretariat has also continued its work advancing alternatives to child detention in the region. Together with the International Detention Coalition, the ADFM Secretariat co-convenes a regional peer-learning platform between five countries: our most recent meeting was held in Putrajaya, Malaysia, in November 2022.

Our twelfth ADFM meeting comes at a very important time for the region: one week after the first ASEAN Summit for 2023, hosted by ASEAN Chair Indonesia in Labuan Bajo, and ahead of the second Global Refugee Forum in Geneva in December 2023. At the 12th ADFM Meeting we look forward to considering the following themes:

- ASEAN's role in the management of forced migration: current activities and future potential;
- Strengthening the region's response to the Rohingya displacement and ongoing boat movements;
- Policy and practice to improve the mental health of refugees in the region.

Please find enclosed the full participant pack, which includes meeting agenda and participant list, three discussion papers and profiles of participants and partner organisations. The ADFM Secretariat is grateful to all who contributed in writing or sharing their feedback and expertise in the development of the discussion papers.
