




























#### **Adelina Kamal**

#### Indonesia

Adelina Kamal is currently an independent analyst and strategist, and formerly Executive Director of the ASEAN Coordinating Centre for Humanitarian Assistance (AHA Centre) and Associate Senior Fellow at the ISEAS-Yusof Ishak Institute. She is a humanitarian, a disaster management professional and an international policy development strategist with more than a quarter of a century experience with ASEAN. Adelina was the first female Executive Director of the AHA Centre for almost five years from 2017 to August 2021, leading ASEAN's response



to major disasters in the region. Prior to that, she worked with the ASEAN Secretariat for over two decades, developing treaties including ASEAN's major regional treaty on disaster management.

Adelina played a key role in the ASEAN response to Cyclone Nargis in Myanmar in 2008, negotiating access and leading ASEAN's first humanitarian operations on the ground. Since leaving the AHA Centre in 2021, she has been a vocal advocate for out-of-the box approaches to the humanitarian crisis in Myanmar. She has written and advocated for localising humanitarian action, building disaster resilience and comprehensive crisis management, and continues to provide strategic advice to international organisations and governments on development financing, governance for disasters & public health emergencies, and regional arrangements.

#### **Andrew Hudson**

#### **Australia**

Andrew is Chief Executive Officer (CEO) of the Centre for Policy Development (CPD). He has 25 years of experience in public policy, advocacy and senior leadership, working with NGOs, the United Nations, the private sector and government. He is an expert in building collaborations and changing systems to improve the lives of disadvantaged people. Andrew joined CPD in June 2021 as inaugural International Director, to build out a new international program for CPD, and became CEO in April 2022. Before joining CPD, Andrew was CEO of Crisis Action in New York, leading a global team of over 50 people in 11 countries. Crisis Action builds coalitions to protect civilians in wars such as Syria, Yemen or South Sudan.



Prior to that, Andrew worked at Human Rights First in New York, where he coordinated UN advocacy, managed the Human Rights Defenders Program and led Latin American work. Andrew has also worked as a lawyer in Australia, with the UN High Commissioner for Refugees in Ecuador and the UN Regional Commission in Thailand. He was Australia's first Youth Representative to the UN. Andrew holds honours degrees in politics and law from the University of Melbourne and a Master of Laws from New York University School of Law. He is a John Monash Scholar and member of the Board of Directors of Australian Progress.

#### Indonesia

Caka Awal is the Director of International Security and Disarmament of the Ministry of Foreign Affairs of Indonesia. Since joining the Ministry of Foreign Affairs in 2000, he has been assigned to various duties in the Ministry, including Directorate of International Organizations, Directorate-General of Protocol and Consular Affairs, Center for Policy Planning for International Organizations, Directorate of ASEAN Political and Security Cooperation, and Directorate of Human Rights and Humanitarian Affairs. 

Ms. Hansen holds degrees in Arts (English) and Law from the University of Sydney and the Australian National University, and in public international law from The Hague Academy of International Law.












#### **Hafsar Tameesuddin**

Ambassador Puja has served in a number of diplomatic postings, including Ambassador to Austria and Slovenia while concurrently the Permanent Representative to the UN and other International Organisations in Vienna; and Ambassador/Deputy Permanent Representative to the UN, WTO and other International Organisations in Geneva. In addition, Ambassador Puja has also served as Vice Chair of the Conference of State Parties, Chemical Weapons Convention; Governor of Indonesia to the International Atomic Energy Agency and a Member of the Indonesian Negotiators for the Aceh Peace Agreement in 2000-2005. He has 24 years experience in the police working across metro and provincial locations in New Zealand and internationally. In January 2020 he took up the role of Irregular Migration Liaison Officer based in Jakarta, before returning to New Zealand in March due to the pandemic. During this time he was the Senior Responsible Officer for the Ministry of Business, Innovation and Employment, where he led the building and implementing of the COVID Community Compliance Model and was later appointed as the National Manager in charge of Irregular Migration and Trafficking in People.



In 2021, Joel returned to Indonesia as the Senior Irregular Migration Liaison Officer for Asia, which includes command of staff across multiple countries. From August 2022 to January 2023 Joel also covered the Police Liaison Officer role for Indonesia. Joel has completed specialised training in relation to command, disaster victim identification, counter terrorism and public order, and holds university qualifications relating to strategy, leadership and change management.

Kanita Sapphaisal is a diplomat (counsellor) currently holding the position as Head of Human Migration Section, under the Social Division within the Department of International Organisations, Ministry of Foreign Affairs (MFA) of Thailand.

Le Thi Nam Huong is currently the Head of the Human Rights Division of the ASEAN Secretariat. A lawyer by training, her professional life has been committed to promoting access to justice and human rights, with over fifteen years working in both the private and public sectors.



Prior to joining the ASEAN Secretariat, Le Thi Nam Huong worked for the United Nations Development Program (UNDP) in Viet Nam and Myanmar on policy advocacy and development programmes, specialising in democratic governance, access to justice, and human rights. She

also co-authored the Vietnam Justice Index reports published in the period of 2010-2017, which gauge public sentiment and experience of ordinary people in access to justice and fundamental rights in the country.

#### **Lilianne Fan**

#### Malaysia

Lilianne Fan is International Director and Co-Founder of Geutanyoë Foundation, a regional humanitarian organisation based in Kuala Lumpur, Malaysia and Aceh, Indonesia, and Deputy Chair of the Asia Pacific Refugee Rights Network (APRRN). She is a cultural anthropologist and humanitarian professional with more than 16 years experience working with refugees, internally displaced persons, and communities affected by conflict and disaster, and currently specialises on the situation of the stateless Rohingya in Rakhine State and in ASEAN. She provides advice to a range of institutions and governments including the UN, the World Bank, ASEAN, the Governments of Malaysia and Indonesia.



Between 2005 and 2012 Lilianne served in several large-scale post-crisis recovery missions, including with the UN-led humanitarian response in post-earthquake Haiti; as Advisor to the ASEAN Special Envoy on Post-Nargis Recovery in Myanmar; as member of the advisory team of the Governor of Aceh on sustainable development following the Aceh peace agreement of 2005; and as Senior Policy Coordinator for Oxfam International in Aceh and Nias from 2005-2008. She holds a Masters in Anthropology from Columbia University, New York.

#### **Muhd Khair Razman Mohamed Annuar**

#### Malaysia

Datuk Muhd Khair is the Deputy Secretary General (Operation) in the Ministry of Human Resources. He has had an extensive career in public service covering the Ministry of Foreign Affairs, Ministry of Energy, Water & Communication, Ministry of Home Affairs, and the Ministry of Human Resources, and also served in the Malaysian Diplomatic Mission in Islamabad, Pakistan, from 1997 to 2002. Prior to becoming Deputy Secretary General, Datuk Razman served as Director General of the Manpower Department at the Ministry of Human Resources.



He is the subject matter expert on migration and trafficking in persons, and previously held the portfolio as the Secretary to the Council for Anti-Trafficking in Persons and Anti-Smuggling of Migrants from 2008 to 2016. He was personally involved in the drafting of the National Action Plan on Anti-Trafficking in Person (NAPTIP) 2010-2015 and NAPTIP 2016-2020. He also established the National Action Plan on Forced Labour 2021-2025, which focuses on awareness, enforcement, labour migration as well as access to remedy and support services with the aim to eliminate forced labour in Malaysia by 2030. He holds LLB (Hons) from the University of Staffordshire and LLM (International Law) from the University of Southampton in the UK and attended the Razak School of Government (RSOG) Leadership Programme at the University of Cambridge, UK.











#### **Naparat Kranrattanasuit**

#### **Thailand**

Dr. Naparat Kranrattanasuit is Assistant Professor and lecturer at the Institute of Human Rights and Peace Studies at Mahidol University (Thailand) She received her Doctor of Juridical Science degree (S.J.D.) from American University Washington College of Law. Her research interests are international human rights law, human rights of marginalised groups of people, and antitrafficking law.



Naparat's recent relevant publications include: ASEAN and Human Trafficking: Case Studies of Cambodia, Thailand and Vietnam; Making Disability Rights Real in Southeast Asia: Implementation of the UN Convention on the Rights of Persons with Disabilities in ASEAN; Inaccessible Public Services in Thailand; Lessons for Perspective Elderly in Thailand: Economic Insecurity; Restricted Right to Employment among Refugee and Asylum Seekers in Indonesia and Its Consequences; Emergency, Exclusion and Inequity in Education of Refugee and Asylum Seeker Children in Indonesia; and Failed Mimicry: the Thai Government's Attempts to Combat Labor Trafficking Using Perpetrators' Means.

#### **Nur Asiah Mohd Shariff**

#### Malaysia

Nur Asiah Mohd Shariff is Assistant Director, Intelligence & National Crisis Management Division at the Malaysian National Security Council. She joined the government in 2009 as a junior officer in the Ministry of Home Affairs, specifically assigned as the desk officer for Multilateral and ASEAN Affairs under the International Division. Part of her task in this role was to conduct analytical studies on international issues and their impact on national security, preparing national reports and providing feedback to issues relating to the security of Malaysia at international fora.



In 2013, Nur Asiah was assigned to the National Security Council as the desk officer for counter terrorism and protective security, before being reassigned to the human security unit in 2017. She is now the Principal Assistant Director, with responsibility for human rights and migration issues. She holds a Bachelor of Social Sciences Degree, majoring in Communication and a Masters Degree in East Asia Studies focusing on refugee management, both from the National University of Malaysia.



Since joining DFAT in 1994, Steve has served overseas as Deputy Ambassador in the Philippines, Minister-Counsellor Political and Economic Section in Indonesia, Economic Counsellor in China and Second/First Secretary Economic in Malaysia. Steve has a Bachelor of Business degree, with honours in Economics, from Curtin University, Western Australia. He has also completed a Leadership in Crisis post graduate course at Harvard's Kennedy School of Government and a Graduate Diploma in Finance and Investment with the Securities Institute of Australia.

Syuhaida Abdul Wahab Zen is the Undersecretary of the National Strategic Office to the Council for Anti-Trafficking in Persons and Anti-Smuggling of Migrants (NSO MAPO). In this role, Syuhaida is responsible for identifying areas for improvement in the Malaysian government's counter-trafficking efforts. She was instrumental in many successful efforts, such as the establishment of the Victim Assistance Specialist (VAS) programme, the multi-stakeholder development of the National Action Plan on Anti-Trafficking in Persons 2021-2025 (NAPTIP 3.0), and the inaugural National Conference on Anti-TIP in 2019. Syuhaida also



leads the IVLP Alumni's Focus Group to support the country's ongoing efforts in improving anti-TIP efforts. She has a Master of Business Administration from National University of Malaysia and a Bachelor's degree in Human Sciences from International Islamic University Malaysia.

#### **Thomas Daniel**

#### Malaysia

Thomas Daniel is a Senior Fellow in the Foreign Policy and Security Studies Programme at the Institute of Strategic and International Studies (ISIS) Malaysia. # National Research and Innovation Agency



The National Research and Innovation Agency (BRIN) was formed by the Indonesian government in 2019, and was established as a new government agency in April 2021.

The mission of the BRIN is to:

- Improve national science and technology capability, research and innovation through improving science and technology capability, strengthening economic transformation, and sustainable development based to increase competitiveness.
- Improve transparent, effective, and reliable government management

This mission includes efforts to respond to science and technology development challenges, and in the 2020-2024 period in the aspects of research and innovation policies, development cooperation and partnerships, increasing research, development, assessment and application of science and technology in several priority focuses of national research and innovation, as well as improving good governance in the context of bureaucratic reform.

In order to achieve BRIN's vision and mission, the strategic objectives that must be achieved are:

- Increasing invention productivity and innovation for competitiveness
- Improving good governance in the context of bureaucratic reform











# Institute of Human Rights and Peace Studies



The Institute of Human Rights and Peace Studies (IHRP) was created following a merger between Mahidol University's Center for Human Rights Studies and Social Development and the Re-search Center for Peacebuilding. IHRP combines the experience and perspective both centers have to offer. IHRP is uniquely interdisciplinary and is redefining the fields of peace, conflict, justice and human rights studies in the Asia Pacific region and beyond.

The Center for Human Rights Studies and Social Development (CHRSD) was established in 1998. For more than ten years, it served as an academic institution specialising in human rights, with a track record in providing postgraduate education as well as training programs to students, human rights workers, human rights defenders, members of civil society organizations and government officials. The Masters in Human Rights started by the CHRSD is the longest running graduate degree program

in human rights in Asia.

The Research Center for Peacebuilding was founded in November 2004 with the impetus to be part of the peaceful solution to conflicts in Thailand, especially the conflict in three southern- most provinces: Pattani, Yala, and Narathiwat. The Center has developed and implemented considerable action and participatory research projects. These projects focus on facilitating cooperative efforts to deal with the conflicts through opening space for dialogue at all levels, reducing violence, and identifying the needs of community and society. Also, the projects provide input for new public policies, in order to transform conflicts and build a just and peaceful society.

Mission: Our focus remains on social and political realities at the com-munity, national and international levels. The IHRP is committed to the advancement of human rights and peace by educating human rights and peace practitioners, promoting outreach programs to community and international organizations, and conducting cutting edge research on important issues. Our mission is to promote learning excellence in human rights and peace, engaging communities in the transformation towards just peace.

# Institute of Strategic and International Studies



The Institute of Strategic and International Studies (ISIS) was established in 1983 as an autonomous, not-for-profit research organization. ISIS Malaysia has a diverse research focus which includes economics, foreign policy, security studies, nation-building, social policy, technology, innovation and environmental studies. It also undertakes research collaboration with national and international organizations in important areas such as national development and international affairs.

ISIS Malaysia engages actively in Track Two diplomacy, and promotes the exchange of views and opinions at both the national and international levels. The Institute has also played a role in fostering closer regional integration and international cooperation through forums such as the Asia-Pacific Round-table, the ASEAN Institute of Strategic and International Studies (ASEAN-ISIS), the Pacific Economic Cooperation Council (PECC) and the Network of East Asian Think-Tanks (NEAT). ISIS is a founding member of the Council for Security Cooperation in the Asia-Pacific (CSCAP) and manages the Council's Secretariat.

ISIS Malaysia has four research programmes:

- Economics: to promote rapid and sustained economic growth and equitable development; to develop actionable policies and to spur institutional change
- Macroeconomic policy: trade and investment, banking and finance; industrial and infrastructure development and; human capital and labour market development
- Foreign Policy and Security Studies: To provide relevant policy analyses on Malaysia's strategic interests, and on regional and international issues, with a focus on the Asia-Pacific Region; including security studies, foreign policy, Southeast Asian politics and military affairs
- Social Policy: demographic and socio-cultural trends that are changing Malaysian society; effective nationbuilding and fostering greater national unity; Malaysian National Blueprint, youth, women and underprivileged communities
- Technology, Innovation, Environment and Sustainability (TIES): Strategic foresight, collaborative research and policy advice to the public sector, businesses and policy audiences; TIES development; and green growth, as well as energy, water and food security.
